Monthly Comment

The Alken Fund Small Cap Europe rose 1.7% in August against -0.7% for the benchmark. This brings the relative performance to 35.9% year to date.

In August, equity markets maintained a robust trajectory, underpinned by a strong reporting season and shifting expectations of interest rate cuts in the US. While economic data remained resilient across regions and manufacturing activity picked up, political instability in Europe continued to pose challenges.

Our stock selection continued to outperform the market. Zegona was the best contributor this month, driven by the disposal of a stake in the Fibre Co. to a financial investor, as well as growing rumours about a potential takeover bid from Telefónica. BFF Bank was another significant contributor, having published encouraging results showing increasing factoring volumes and a strong capital position.

In contrast, VusionGroup was softer reflecting some concerns about a slight decline in order intake during the second quarter despite a strong set of results. We remain very positive on this name as the growth trajectory is robust as the technology continues to gain momentum across retailers.

The outlook for the market has not changed materially, with geopolitical instability and its impact on economic growth still dominating the headlines. Despite the uncertainty, equity valuations are not cheap, but we continue to see dispersion across stocks, which provides good opportunities for generating alpha through an active approach.


Market Capitalisation¹
